✓	✓ CHF Signalments, treatment and F/U
✓	✓ Depression Assess for risk; treatment/referral interventions
✓	✓ Diabetes Instruct med, foot care, s/s; Assess skin of lower extremities
✓	✓ ER Use Identify reason
✓	✓ Falls Assess for risk; prevention measures
✓	✓ Immunizations Influenza and pneumonia confirmation/division if not
✓	✓ Medication Issues F/U with physician within 1 calendar day
✓	✓ Medication Education Instruct to monitor effectiveness, drug reaction, side effects, how/when to report problems
✓	✓ Pain Assess, instruct on relief measures, evaluate effectiveness
✓	✓ Taking High Risk Drugs Instruct on risk prevention for bruise, hypoglycemia, anticoagulants, narcotics, sedation
✓	✓ Skin AssessmentR risk assessment & weak; provide prevention interventions
✓	✓ Pressure Ulcer Size, moist wound healing treatment, if applicable
✓	✓ UTI Assess risk for treatment prevention
